China ready for talks with India on corridor with Pak

Beijing, Jan.30: China on Monday said it is ready to hold talks with India to resolve their differences on the contentious \$50 billion China-Pakistan Economic Corridor (CPEC) that passes through PoK. India has objected to the \$50 billion CPEC as it passes through the disputed Pakistan-occupied Kashmir. Asked about Indian Ambassador to China Gautam Bambawale's interview to state-run Global Times in which he had said that differences on the CPEC should not be swept under the carpet, Chinese foreign

ministry spokeswoman Hua Chunying said China is willing to hold talks with India in this regard. "I noted the relevant report. Regarding the CPEC, China has repeatedly reiterated our position. As to the differences between China and India, China stands ready to communicate and hold talks with India to seek a proper solution so that these differences will not affect our general national interests. This best serves the interests of the two countries," she said. As to any differences arising between the two countries, they can be

Pak army arming LeT in J&K: Envoy

New Delhi, Jan.30: Pakistan Army has been supplying military equipment to Lashkar-e-Toiba in Kashmir and Taliban in Afghanistan, claimed Afghanistan envoy to the US Majeed Qarar, today. The allegation was made following an attack on the Afghan Military Academy in Kabul by a group of suicide bombers earlier today. At least five soldiers were killed in the attack and 10 wounded.

"The night vision goggles found with Taliban attackers in Maiwand's ANA base were military grade goggles (not sold to the public) procured by Pakistan Army from a British company and supplied to Lashkar-e-Tayyeba in Kashmir and Taliban in Afghanistan. Lashkar-e-Tayyeba is an international terrorist organisation", Qarar tweeted.

Qarar's claims about the Pakistan army supplying Kashmir-focussed LeT bolster India's contention that terror in the state is being fomented by the Pakistani establishment. Earlier this month, the National Investigation Agency filed a chargesheet against Saeed, Hizbul Mujahideen head Syed Salahuddin and 10 others in the Jammu and Kashmir terror funding case alleging that they along with their Pakistani handlers, separatists, stone-pelters and terrorists are creating an atmosphere of terror and fear in Kashmir.

Babylon, Jan 30: A small plane has landed on a New York beach and flipped over, but there are no reports of serious injuries.

State parks official George Gorman says

the emergency landing occurred Monday morning at Robert Moses State Park in Babylon, on Long Island.

the edge of the surf, its wheels in the air and its tail in the sand.

WABC says a pilot and two teenage flight students were aboard the plane when it apparently developed mechanical problems.

US lifts ban on refugees from 11 nations

Washington, Jan.30: The United States announced on Monday it was lifting its ban on refugees from 11 "high-risk" countries, but said those seeking to enter the US would come under much tougher scrutiny than in the past. The 11 countries, hit with a ban in October in the Trump administration's revised refugee policy, have not been identified officially.

But refugee groups say they comprise Egypt, Iran, Iraq, Libya, Mali, North Korea, Somalia, South Sudan, Syria and Yemen.

Applicants from 11 countries, unnamed but understood to include 10 Muslim-majority nations plus North Korea, will face tougher "risk-based" assessments to be accepted.

"It's critically important

that we know who is entering the United States," said homeland security secretary Kirstjen Nielsen.

"These additional security measures will make it harder for bad actors to exploit our refugee program, and they will ensure we take a more risk-based approach to protecting the homeland."

Speaking anonymously, a senior administration official told journalists that the policy of enhanced security assessments was not designed to target Muslims. "Our admissions have nothing to do with religion," the official said, adding that there is "nothing especially novel" about tougher screening for countries deemed to have a higher level of risk.

Trump warns of Iran's 'destabilising' efforts

Washington, Jan 30: President Donald Trump has accused Iran of destabilising the Middle East, as his United Nations ambassador sought to bolster that argument by showing fellow envoys what she said was debris from an Iranian missile fired at Saudi Arabia.

Meeting at the White House with members of the UN Security Council and his own national security team, Trump

said the group had "much work" to do. He drew up a daunting list of objectives, including countering "Iran's destabilisation activities," ending the Syrian conflict, combating terrorism and denuclearising North Korea. Earlier, UN Ambassador Nikki Haley took her fellow Security Council members to Joint Base Anacostia-Bolling in Washington to show them the missile debris.

Tickets to Trump speech reprinted over spelling mistake!

Washington, Jan 30: Tickets inviting guests to President Donald Trump's first official State of the Union address tomorrow had to be reissued after a misprint.

The tickets read, "Address to the Congress on the State of the Union." Lawmakers had fun with the glitch: "Looking forward to tomorrow's State of the Union," Senator Marco Rubio of Florida tweeted with a picture of the invite.

Rep. Raul Grijalva of Arizona used the glitch to jab at the secretary of education: "Just received my ticket for the State of the Union. Looks like @BetsyDeVosEd was in charge of spell checking... #SOTUnion" The House Sergeant at Arms is responsible for printing and distributing the tickets. An official said a correction was immediately made and all but a dozen tickets have been exchanged.

Trudeau decries Islamophobia

Quebec, Jan 30: Prime Minister Justin Trudeau called for Canadians to stand up against Islamophobia and discrimination as he paid tribute to six Muslims killed a year ago at a Quebec mosque.

Trudeau lamented that acts of hate and discrimination have become "commonplace"

or "even tolerated," saying in parliament that "it should never have come to this point." "We cannot bring back those who perished, but we owe it to them to fight the very sentiment that caused their loss. We owe it to them to speak up and stand tall and explicitly against Islamophobia and discrimination in all its forms," he said.

On January 29, 2017, just after the Sunday evening prayer, a gunman burst into the mosque in a residential neighbourhood of Quebec City and opened fire on worshippers. In addition to the six deaths, four

of the victims suffered permanent disabilities in what remains one of the worst attacks on an Islamic place of worship in the West.

In the aftermath, thousands of people, including Trudeau, gathered in Quebec City to express their support for the Muslim community. The alleged perpetrator, Alexandre Bissonnette, was formally charged in October for the murder of six people and the attempted murder of another 35 worshippers in the mosque. His trial is scheduled to begin in late March.
